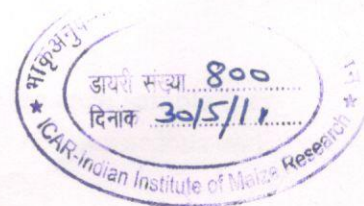

Schedule of Charges



1. DUS Characterization and evaluation of the maize genotypes -seed to seed @ Rs.50,000/ per sample
2. Digitization of important traits in maize genotypes -seed to seed @ Rs.18,000 per sample
3. Screening of maize germplasm (100 lines) against *C. partellus* @ Rs. 236440/-
4. screening of maize germplasm (100 lines) against *S. inferens* @ Rs. 235440/-
5. Screening of maize germplasm (100 lines) against *Atherigona* sp @ Rs. 133080/-
6. Testing of insecticides (single insecticide) @ Rs. 75000/-
7. Total carbon in soil (Dumas method): Rs. 250 per grinded prepared sample by Automatic C-S analyzer
8. Foodgrains seed sample grinding (20 g): Rs 150 per sample by Retsch Mill using Zirconium ball in Teflon chamber for iron and zinc analysis.
9. NDVI recording: Rs 50 per observation + transportation and TA for expert using hand held green seeker sensor.
10. SPAD meter reading: Rs 50 per observation + transportation and TA for expert using SPAD meter.
11. Penetration resistance: Rs 1000 per observation + transportation and TA for expert using Cone penterotmeter up to 60 cm depth in moist soil in condition.
12. Infrared temperature and CTD: Rs. 100 per reading + transportation and TA for expert using Infrared thermometer having Skyspy component that records ambient and infrared temperature simultaneously and gives real time CTD.
13. Protein quality of maize (protein, lysine and tryptophan) per sample @ Rs. 10000/-
14. Oil content in maize (per sample) @ Rs. 5000/-
15. Starch content (per sample) @ Rs. 5000/-
16. Screening for heat stress (single entry) per year: Rs 60,000/-
17. Screening for drought stress (single entry) per year: Rs 60,000/-
18. Screening for disease resistance (single entry) per year: Rs 60,000/-
19. Testing of new molecules for control of maize diseases (per molecule/location/season basis)- Rs 20,000/-

All the users are required to submit MSDS (Material Safety Data Sheets) for each sample they submit and a certificate stating that the samples submitted are non-toxic / non-hazardous and that the sample does not require special precaution while handling.

Kindly add GST 18% (w.e.f. from 1st July 2017) on Instrument Charges

1. Dispatch address will be same as address on letter head.
2. GST is applicable to all the users and is calculated as per current rate 18% (w.e.f. from 1st July 2017).
3. All the samples should accompany the payment, in order to be considered for registration and analysis. All the payments should be in favour of " Director, ICAR IIMR Ludhiana" but the Demand Drafts should be sent to "Director, ICAR – IIMR, PAU Campus, Ludhiana"
4. The payment should be made in advance by a only Demand Draft (DD) in favour of: " Director ICAR IIMR Ludhiana ."
5. The DD should be rounded off the nearest figure (integer value).

Example: IF total charges (including tax etc.) comes out to be Rs.569.67/-(ie greater than or equal to 50 paise) then DD amount should be rounded off to Rs.570/-. If total charges (including tax etc) comes out to be Rs. 569.47/-(i.e. less than 50 paise) then DD amount should be rounded off to Rs. 569/-
