Therefore, the interested candidate who are meeting the required qualifications and conditions will send their **bio-data along with the self-attested photocopies of all the required certificates/documents and recent passport sized photograph** to the concerned PI of the Project through email at least by **04.10.2020**
2. The access to the video conferencing shall be provided to the candidate. Details viz. login id and password etc. shall be uploaded by the PI on ICAR-IIMR website (<https://iimr.icar.gov.in>) at least one day prior to the conduct the interview. Hence, all the candidates are advised to visit the website regularly. Candidate may also contact to the PI in case of any problem regarding online access to be in interview.
3. The whole interview will be recorded and the candidates should attend the interview with video, so that identity can be confirmed.
4. No second chance of interview shall be given, if there has been no access to the interview due to poor network etc. at the end of candidate of otherwise also.
5. The post is purely temporary and will be filled on contractual basis initially up to 31st March 2021 except or till the validity of the respective project, whichever earlier. In case of YPs maximum term shall not be more than of two years.
6. The contract may be extended periodically subject to satisfactory performance till the termination of the project.
7. Candidate shall not claim regular appointment at the Institute, as the post is co-terminus with the project.

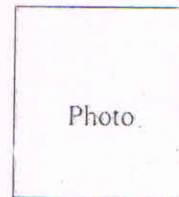
